### GENERAL INFORMATION

Bronc Total is a proprietary blend of ammonium sulfate sequestering agent and surfactants with nonionic properties. Bronc Total should be used to improve the performance of postemergence herbicides where an ammonium sulfate based product is required. Bronc Total is specially formulated for use with many postemergent herbicides, which perform best when mixed with ammonium sulfate in combination with a nonionic surfactant.

Bronc Total replaces the need for 28% nitrogen solution, crop oil concentrates, vegetable seed oils and nonionic surfactants. When used at the recommended rates, Bronc Total can increase the performance of various herbicides that may require combinations of the above additives.

### DIRECTIONS FOR USE

Rates of Bronc Total may vary with the conditions of applications. Fill spray tank one half (1/2) full with water. Add the proper amount of Bronc Total and herbicide. Add the remainder of the water. By-pass agitation is sufficient when using Bronc Total, but it should continue until all of the solution has been sprayed.

**DO NOT ADD THIS PRODUCT AT A RATE WHICH EXCEEDS 5% OF THE FINISHED SPRAY VOLUME.**

### USE RATES

Use 1 to 4 quarts of Bronc Total per 100 gallons of Spray Solution.
