WILBUR-ELLIS Ammonium Sulfate Solution is specially formulated to be used with many postemergence type herbicides, which perform best when mixed with ammonium sulfate.

This Ammonium Sulfate Solution is filtered through a special process to remove impurities and other contaminants generally associated with dry or other liquid ammonium sulfate products. This lack of sedimentation reduces nozzle plugging, wear and corrosion of equipment when used with post emergent herbicides that call for an ammonium sulfate additive.
